

**Minutes of the DDC Meeting with all Heads of Departments held on 29/12/2016 at 10.00 AM in the Conference Hall of Deputy Commissioner's Office Hailakandi.**

The meeting was presided over by Shri Moloy Bora, IAS, Deputy Commissioner, Hailakandi. At the outset the Deputy Commissioner welcomed all the members present in the meeting.

Department-wise and scheme-wise discussions were held as under:

1. **PWD(Rural Road)** : The Executive Engineer, PWD(RR), Hailakandi informed that works of 5(five) Nos. of PMGSY schemes are yet to be started. The Deputy Commissioner, Hailakandi directed the Executive Engineer, PWD(RR), Hailakandi to submit the latest status report of all the pending and incomplete works/schemes under PMGSY. He said that Dept. should ensure whether the concerned contractors started the works again.
2. **PWD (Naional Highway)** : The Asstt. Executive Engineer, PWD(NH) informed that the works of approach road at Dhaleswar by-pass and Katlicherra by-pass were going on. The Deputy Commissioner instructed the AEE, PWD(NH) to expedite the works and also instructed to submit a report on inter-state border road for CM's meeting.
3. **PWD (State Road)** : The Asstt. Executive Engineer, PWD(SR), Hailakandi informed in the meeting that the repairing work of Algapur -Mohanpur Road was completed, but no fund received so far. The Deputy Commissioner directed the AEE concerned to submit a report with note along with requirement of fund.
4. **PWD(Bldg)** : In reply to a query, the AEE, PWD(Bldg), Hailakandi informed that the construction works of I.T.I. and Judicial Building will be completed by March, 2017. He also stated that works of DIET is almost complete. Deputy Commissioner asked the AEE, PWD(Bldg) to expedite the construction works of Circle office at Lala and complete the work without any further delay.
5. **Agriculture** : Sr. ADO, Hailakandi informed that 5163 Nos. of soil samples were collected and analysed and Soil Health Card to be issued to all concerned farmers. DAO also informed that Agriculture deptt. has received 5(five) Nos. of Mini Soil Testing Laboratory (Mridparikhshak) for analysing 1000 Nos. of samples. On completion of 70% of such samples, reagents etc. will be provided by State Head Quarter for rest samples. He also stated that it is very difficult to achieve the target with limited manpower, infrastructure etc. so it is decided that the KVK, Hailakandi will analyse 50% of samples (i.e. 2580 Nos.) print SHC for concerned farmers and rest 50% target will be achieved by Agril. Deptt. Hailakandi. Deputy Commissioner asked the DAO to give top most priority for collection of Soil samples. PD, DRDA also assured to provide necessary fund @ Rs.200/- per sample to KVK, Hailakandi being the cost for the analysis of 2580 Nos. samples and printing SHC.
6. **Agriculture (Engineering)**: The Sr.ADO, Hailakandi informed that 2(two) Nos. of Power Tillers under RKVY have already been distributed in the Krishak Shibir on 17<sup>th</sup> of Dec., 2016 and rest are being distributed. He also informed that 40 Nos. of Power Tillers under BGREI and 18 Nos. under NFSM will be distributed shortly on completion of selection process and opening of joint bank account for all the beneficiary groups. Deputy Commissioner directed the Agril. Deptt. to apprise the matter to the Hon'ble MLAs of the district. Deputy Commissioner also informed that he wanted to establish CSIR Project at Algapur and Lala, in this respect Agril.Deptt. is instructed to submit a detailed report to the Govt.
